THE ANTIQUITIES ORDINANCE (CHAPTER 188)

Notice under Section 19

I, Akila Viraj Kariyawasam, Minister of Education do hereby give notice that I intend to make an Order under section 18 of the Antiquities Ordinance (Chapter 188) declaring the Monuments specified in the schedule to this Notice, to be "protected Mounuments" for the purpose of the aforesaid Ordinance.

Every such objection shall be in writing and shall contain a statement of the grounds upon which such objection is made.

SCHEDULE

MONUMENTS TO BE DECLARED AS PROTECTED MONUMENTS

01. The hillock of ancient *Chaithya* and three sites containing ruins of buildings in the premises called Kovilkanda No. 03 of Dikwela Road belonging to Himbudawa village situated in the Grama Niladhari Division No. 1605, Thambakanda in the Divisonal Secretary's Division of Pannala in Kurunegala District, North - Western Province.



02. The rock plain with hillock of ancient ruins in the land called Kongahamolahena Weheragawahena *alias* Kadurugahamulawaththa belonging to Pandawa village situated in Grama Niladhari Division No. 1352, Diggallagedara in the Divisional Secretary's Division, Panduwasnuwara (West) in Kurunegala District in North Western Province.
03. The Drip ledged cave at the premises of Kuruwalena Rajamaha Vihara belonging to Yatiwilla village situated in Grama Niladhari Division No. 647, Bandaragala in the Divisional Secretary's Division, Mawathagama in Kurunegala District in North Western Province.
04. The Molamure cemetery belonging to Makandura village situated in Grama Niladhari Division Mankandura in the Divisional Secretary's Division, Godalawela in Rathnapura District in Sabaragamuwa Province.
05. Hillock of ancient ruins and *Bodhi Prakara* on the rock plain called belonging to Kotagama village situated in Grama Niladhari Division No. 09, Kotagama in the Divisional Secretary's Division, Rambukkana in Kegalle District in Sabaragamuwa Province.
06. Two drip ledged caves belonging to Dimbulgamuwa village situated in Grama Niladhari Division No. 14 B, Dimbulgamuwa in the Divisional Secretary's Division, Kegalle in Kegalle District in Sabaragamuwa Province.
07. Drip ledged cave at the premises called Mothajjewaththa belonging to Nawandala village situated in Grama Niladhari Division Heenatipana in the Divisional Secretary's Division, Mawanella in Kegalle District in Sabaragamuwa Province.
08. Ancient Awasa (Dwelling) at the premises of Iddamalpana Rajamaha Vihara belonging to Harigala village situated in Grama Niladhari Division Kinigama in the Divisional Secretary's Division, Galigamuwa in Kegalle District in Sabaragamuwa Province.
09. Drip ledged cave at the Namaldeniya village situated in Grama Niladhari Division No. 146/B, Bodhimaluwa in the Divisional Secretary's Division, Kuruwita in Rathnapura District in Sabaragamuwa Province.
10. Ancient Shrine at the premises of Jayasinghama Purana Vihara belonging to Karaputugala village situated in Grama Niladhari Division No. 324, Karaputugala in the Divisional Secretary's Division, Kamburupitiya in Matra District in Southern Province.
11. Ancient Shrine with ancient paintings at the premises of Keerthi Shri Thejowarama, Kithsiripura situated in Grama Niladhari Division No. 279B, Kithsiripura in the Divisional Secretary's Division, Mulatiyana in Matara District in Southern Province.
12. The Dutch Reformed Church and premises with ancient *Sohon Puwaru* (Grave Monument Slab) at the place of Rate No. 12 of Church Street in Galle Fortress situated in Grama Niladhari Division No. 96 D, Galle fortress in the Divisional Secretary's Division, Four Gravets, Galle in Galle District in Southern Province.
13. Anglican Church Building at the Place of Rate No. 20 of Church Street in Galle Fortress situated in Grama Niladhari Division No. 96 D, Galle Fortress in the Divisional Secretary's Division, Four Gravets, Galle in Galle District in Southern Province.
14. Methodist Church building at the Place of Rate No. 32 of Light House Street in Galle Fortress situated in Grama Niladhari Division No. 96 D, Gall Fortress in the Divisional Secretary's Division, Four Gravets, Galle in Galle District in Southern Province.
15. *Dharamashala* belonging to the premises of Sudharmalaya Vihara at the No. 07 of Sudharmalaya Street in Galle Fortress situated in Grama Niladhari Division No. 96 D, Galle Fortress in the Divisional Secretary's Division, Four Gravets, Galle in Galle District in Southern Province.
16. Ancient *Chaitya*, Pandal, *Prakara Bemma* (Enclosure Wall), ancient *Awasa* (Dwellings) and *Sobhi Ganinnanaselage Sohon Puwaruwa* (Grave Monument Slab) at the premises of Sri Wardhanarama Purana Vihara in Kaluwella village situated in Grama Niladhari Division No. 96C, Kaluwella in the Divisional Secretary's Division, Four Gravets, Galle in Galle District in Southern Province.

17. The shrine with ancient paintings at the place called Gurukanda Vihara belonging to Batheegama village situated in Grama Division No. 451 D, Batheegama Central in the Divisional Secretary's Division, Dikwella in Matara District in Southern Province.
18. The ancient building called "Jaya Niwasa" belonging to Matara Bodhi Protection Council at Kumarathunga Mawatha belonging to Nupe village situated in Grama Niladhari Division No. 324, in the Divisional Secretary's Division, Matara in Matara District in Southern Province.
19. Drip ledged cave in Ambagaspitiya village situated in Grama Niladhari Division No. 307A, Ambagaspitiya in the Divisional Secretary Division, Mahara in Gampaha District in Western Province.
20. Ancient building called Senanayaka Wallawwa belonging to Kandawal village situated in Grama Niladhari Division No. 70, Upper Kandawala in the Divisional Secretary Division, Katana in Gampaha District in Western Province.
21. Two ancient *Awasas* (Dwelling) and Sakmanmaluwa (Walking path) in the premises of Sudharmarama Purana Vihara belonging to Morawinna village situated in Grama Niladhari Division No. 689A, in the Divisional Secretary Division, Panadura in Kalutara District in Western Province.
22. *Ancient Dagoba*, ruins of buildings and other archeological evidences in the premises of Sri Agbo Purana Vihara belonging to Thissapura village situated in Grama Niladhari Division No. 228G, Mollipathana-North in the Divisional Secretary Division, Thambalagamuwa in Trincomalee District in Eastern Province. (8° 26' 59.2" N- 81° 04' 14.7"E)
23. Ancient buildings built of stone slabs in paddy land adjacent to Thissapura-Saliyapura road belonging to Mollipothana village situated in Grama Niladhari Division No. 228F, Mollipathana in the Divisional Secretary Division, Thambalagamuwa in Trincomalee District in Eastern Province. (8° 25' 37.9" N- 81° 03' 50.6"E)
24. *Athani* stone (pillar) inscription at the place called 4th Canal belonging to village No. 08 situated in Grama Niladhari Division Thissapura Unit 08 in the Divisional Secretary Division, Thambalagamuwa in Trincomalee District in Eastern Province (8° 26' 41.7" N- 81° 04' 23.2"E)
25. Ancient building called Elathpoe-Cottage at Rent No. 23 and 25 at Lady Macalom Street situated in Grama Niladhari Division No. 535, Nuwaraeliya in the Divisional Secretary's Division, Nuwaraeliya in Nuwaraeliya District in Central Province.
26. Weherapitiya premises with ruins of ancient buildings and other archeological evidences belonging to Werappitti village situated in Grama Niladhari Division No. J/25, Karainagar South West, in the Divisional Secretary Division, Karainagar in Jaffna District in Northern Province. (9° 43' 50" N- 079° 51' 45"E)
