#### **Declaration under Section 5**

I, Wijesundara Mudiyanselage Thilakarathna Bandara Ekanayaka, Minister of Lands (Acting) hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.
