THE LAND REFORM LAW, No. 1 OF 1972

Order under Subsection (4) of Section 27A

BY virtue of the powers vested in me by subsection (4) of the Section 27A of the Land Reform Law, No. 1 of 1972 as amended by the Land Reform (Special Provisions) Act, No. 39 of 1981, I, John Anthony Emmanuel Amarathunga, Minister of Land, Tourism and Christian Affairs, do by this Order -

- (a) amend the Order, made under subsection (I) of Section 27A of the Land Reform Law, No. 1 of 1972, and published in *Gazette Extraordinary* No. 456/4 of July 1, 1987 relating to the land called and known as Hantane Estate morefully described in the First Schedule to this Order and which had vested in the National Housing Development Authority established by the National Housing Development Authority Act, No. 17 of 1979 as last amended by National Housing Development Authority (Amendment) Act, No. 30 of 1999, by revoking, the said Order as relates to the extent of land called Hantane Estate specified in the Second Schedule ; and
- (b) State that upon revocation, such extent of land as specified in the Second Schedule to this Order, shall re-vest in the Land Reform Commission.
