ORDER UNDER SUB - SECTION (4) OF SECTION 27 A OF THE LAND REFORM ACT No. 1 OF 1972 OF THE NATIONAL STATE ASSEMBLY

BY virtue of the powers vested in me by Section 27 A (4) of the Land Reform Act No. 1 of 1972 amended by the Land Reform (Special provisions) Act, No. 39 of 1981 of the National State Assembly, I, John Anthony Emmanuel Amarathunga, Minister of Lands, do hereby,

- (a) Amend the Order by way of revocation of the order made on the portion of land in relation to the extent of land of the land called "Harepark Estate (Dehigolla Division)" depicted in the Second Schedule of the Order made under section 27 A (1) of the Land Reform Act, No. 1 of 1972, Published in the *Gazette Extraordinary* No. 195/ 6 dated 31st May 1982 in respect of the Land called and mentioned as Harepark Estate (Dehigolla Division), which has been alienated to Sri Lanka State Plantation Corporation established under Sri Lanka State Plantation Corporation Act, No. 04 of 1958 and depicted comprehensively in the First Schedule of this order, due to not following the Order or conditions of the agreement made for this alienation of the Land to Sri Lanka State Plantation Corporation.
- (b) It is hereby declared that the extent of Land depicted specifically in Second Schedule of this order is alienated again to the Land Reform Commission as a result of this revocation.
