IN pursuance of Section 12(1) of the Registration of Electors Act, No. 44 of 1980, it is hereby notified that the revision of registers of electors for the year 2017 has commenced on 15th May 2017.

Each Local Authority

Portion of the Electoral Register containing names of all electors whose ordinary residency in the relevant local authority is confirmed

Each Grama Niladhari Office

Portion of the Electoral Register containing names of all electors whose ordinary residency in the relevant Grama Niladhari Division is confirmed



03. Every person qualified to be an elector in a certain Electoral District may take action to peruse the Electoral Register and ascertain whether his/her name is in the register or not.

04. From 15.05.2017 enumerators will distribute enumeration forms to chief occupants of each household to obtain particulars of persons, who are qualified to be registered as electors for the year 2017. Chief occupants are required to assist the enumerators by submitting correct information of all persons, who satisfy eligibility requirements to register as electors under his/her household, through these forms, without delay.
