**SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007**

**Order under Section 2**

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Ravi Karunanayake, Minister of Finance, the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of list of the commodities specified in Column I of the Schedule hereto a Special Commodity Levy, at the rates specified in the corresponding entries in Column II of that Schedule.
