THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthony Emmanuel Amarathunga, Minister of Lands, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act:

The allotments of lands total extent of about 0.1391 hectare, depicted as Lots. A, B, C and D in Advance Tracing No. Maha/HTR/2015/284 and dated 08.09.2015, prepared by the Senior Superintendent of Survey in Kandy, situated in the Village of Hatharaliyadda in the Palle Palatha Korale Minor Division in the Hatharaliyadda Divisional Secretary's Division in the Kandy District in the Central Province and bounded as follows:

01. Lot 'A' – Alipitiwela Kumbura – Extent:0.1066 Hectare

North: Alipitiwela Kumbura claimed by the State and Alipitiwela Kumbura claimed by Bandula Gunasekara; East and South: Canal; West: Road (Pradeshiya Sabhawa) and Alipitiwela Kumbura claimed by T.G. Thalagahagoda.

02. Lot 'B' – Alipitiwela Kumbura – Extent:0.0255 Hectare

North: Canal; East: Alipitiwela Kumbura claimed by Senanayaka; South: Polwaththe Canal; West: Road (Pradesheeya Sabhawa).
