I hereby given notice, Sub-section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following land/ servitude which is required for a public purpose.

Description of the land/servitude to be acquired:

Portions of land described in the schedule attached, situated in the Uda ellegama village in the Soranathota Divisional Secretary's Division in Badulla District, in the province of Uva, containing about 0.6359 hectares in extent and depicted in the supplement No. 40 of the village Plan No. 88, prepared by the surveyor General.
