**WAGES BOARD FOR THE FLOWERS, ORNAMENTAL PLANTS, VEGETABLES AND FRUIT GROWING AND EXPORT TRADE**

IT is hereby notified under Section 29(3) read with Section 33(3) of the Wages Boards Ordinance (Chapter 136) the determination relating to the minimum rate of wages in respect of workers engaged in Flowers, Ornamental Plants, Vegetables and Fruits Growing and Export Trade specified in the Schedule hereto made by the Commissioner of Labour under Section 33(2) of the aforesaid Ordinance in pursuance of the authority conferred on him by an order made by Hon. Minister of Labour, under Section 33(1)(a) of the Ordinance and published in *Gazette Extraordinary* No. 1916/12 of May 27, 2015 has been approved by the Hon. Minister of Labour, Trade Union Relations and Sabaragamuwa Development.

The determination shall come into force on the 01st August, 2017.

*Skilled :*

Tissue and seed cultivators, workers engaged in grafting, workers engaged in arranging flower plants, flowers and branches for export and sale, workers engaged in arranging ornamental plants and parts of plants, quality controllers, workers engaged in spraying fungicides, insecticides and manuring packers, store keepers, men-in-charge of workers administration, workers engaged in activities which need a training.

*Semi-Skilled :*

Workers engaged in preparation of nursery beds, planting seedlings and maintenance, product pluckers and collectors, store assistants other semi-skilled workers.

*Un-Skilled :*

Workers engaged in preparation of land, loading and un-loading, labourers, workers engaged in other activities which do not need a training.
