All that allotment of divided and defined of lands depicted in as Lot Nos. 1, 2 and 3 of Plan No. P. P. Maha. 5345 dated 28th June, 2002 made by Mr. K. Kathatharan Government Surveyor in respect of a land situated in the Village called Deiyannewela in Word No. 17, Kotugodella within the Municipal Limits of Kandy, Minor Division of Gangawata Korale in the Divisional Secretary's Division of Kandy and Gangawata Korale in the District of Kandy in Central Province which lands are bounded as follows and containing in extent of 5.0835 Hectares.
