#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 7

I hereby notify, under Sub-section 7, of the Land Acquisition Act, as Amended by the Land Acquisition (Amendments) Act, No. 28 of 1964, that the Government intends to acquire the following land/servitude which is required for a public purpose.
