Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act Such Servitude is to be acquired from which lands are described below.

1. **Description of Servitude** - For the construction at access to Kumbukkana Intake of Monaragala - Buttala Integrated water Supply Project.

2. **Description of the land** - Three (03) allotments of land containing in extent about 0.1220 Hectare depicted as Lots A, B and C in the Advance Tracing No. MO/BTT/2015/725 and dated 24.06.2016 prepared by the Surveyor-General situated in the Buttala Wedirata Korale Minor Division in the Village of Okkampitiya in the Divisional Secretary's Division of Buttala in Monaragala District Uva Province and Bounded as follows:

01. **Lot 'A' – Elamanaya – Extent: About 0.0619 Hectare**

North: Elamanaya claimed by E.A. Anulawathi; East: Elamanaya claimed by E.A. Anulawathi and canal; South: Canal, Elamanaya claimed by E.A. Anulawathi and Kumbukkan Oya; West: Elamanaya claimed by E.A. Anulawathi and Kumbukkan Oya.

North: Canal and Elamanaya Owners could not be found; East: Elamaya owners could not be found and Road (R.D.A.); South: Road (R.D.A.) and Elamanaya Owners could not be found; West: Elamanaya owners could not be found and canal.
