THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilake, Minister of Lands and Parliamentary Reforms hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land from 'A' to 'E' in total extent of about 0.8413 Hectare depicted in the Advance Tracing No. KE/YTY/2017/44 and dated 19.03.2017 prepared by the Surveyor General situated in the Village of Ganepalla in the Grama Niladhari Division of No. 135, Ganepalla in Minor Division of Kithulgal Palatha in the Divisional Secretary's Division of Yatiyantota in Kegalle District in the Sabaragamuwa Province and bounded as follows:

01. Lot 'A' - Ganepalla Estate(Upper Division) – Extent: 0.2326 Hectare

North: Ganepalla Estate (Upper Division); East: Ganepalla Estate (Upper Division) and Lot B (Road); South: Lot B (Road); West: Lot B (Road) and Stream.

02. Lot 'B' - Ganepalla Estate(Upper Division) – Extent: 0.0703 Hectare

North: Lot A, Ganepalla Estate (Upper division) and Lot C; East: Lot A, Ganepalla Estate (Upper division) and Lots C and E; South: Lot C, Ganepalla Estate (Upper division), Lots E and D; West: Lot D, Stream and Lot A.

03. Lot 'C' - Ganepalla Estate(Upper Division) – Extent: 0.1869 Hectare

North: Lot B(Road) and Ganepalla Estate (Upper Division); East: Ganepalla Estate (Upper Division); South: Ganepalla Estate (Upper Division) and Lot B(Road); West: Lot B(Road).

04. Lot 'D' - Ganepalla Estate(Upper Division) – Extent: 0.2959 Hectare

North and East: Lot B(Road); South: Lot B(Road) and Stream; West: Stream.

05. Lot 'E' - Ganepalla Estate(Upper Division) – Extent: 0.0556 Hectare

North: Lot B(Road); East: Ganepalla Estate (Upper division); South: Stream; West: Lot B(Road).
