Land Acquisition Notices

THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunathilake, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act:

Four allotments of land described in below names and extents and depicted as Lots 'A', 'B', 'C', and 'D' in Advance Tracing No.GAM/DOM/2016/271 dated and 10.08.2016 prepared by the Surveyor General situated in the Village of Radawana in Gangabada Paththuwa Minor Division in the Divisional Secretary's Division of Dompe in Gampaha District in Western Province and bounded as follows:

01. Lot 'A' – Alubogahakumbura – Extent: 0.4537 Hectare

North: Ela; East: Lots B and C; South: Lot D and Paddy field called Alubogahakumbura claimed by L.G. Lalitha; West: Paddy field called Alubogahakumbura claimed by L.G. Lalitha.

02. Lot 'B' – Alubogahakumbura – Extent: 0.0985 Hectare

North: Ela; East: Paddy field called Alubogahakumbura claimed by P.A. Sumanawathi and Others; South: Lot C; West: Lot A and Ela.

03. Lot 'C' – Alubogahakumbura – Extent: 0.1599 Hectare

North: Paddy field called Alubogahakumbura claimed by P.A. Sumanawathi, Lots A and B; East: Paddy field called Alubogahakumbura claimed by P. A. Sumanawathi, Lot B and Paddy field called Alubogahakumbura claimant not known; South: Lot D and Paddy field called Alubogahakumbura claimant not known; West: Lots D and A.

04. Lot 'D' – Alubogahakumbura – Extent: 0.8068 Hectare

North: Lots A and D, Paddy field called Alubogahakumbura claimed by L.G. Lalitha; East: Paddy field called Alubogahakumbura claimant not known and Lot C; South: Paddy field called Alubogahakumbura claimant not known and Ela; West: Paddy field called Alubogahakumbura claimed by L.G. Lalitha and Ela.
