A Statute to amend the Appropriation Statute No. 04 of 2016 as amended by Statute No. 01 of 2017

APPROPRIATION STATUTE - 2017

A Statute to amend the Appropriation Statute No. 04 of 2016 as amended by Statute No. 01 of 2017 of the Sabaragamuwa Provincial Council of the Democratic Socialist Republic of Sri Lanka.

1. This statute may be cited as the Sabaragamuwa Provincial Council Appropriation (Amendment) Statute No. 02 of 2017 and shall come into operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.



2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Thirty Billion, Twenty Two Million Seven Hundred and Eighty Seven Thousand Two Hundred and Seventy Eight and Cents Eighty Six only (Rs. 30,022,787,278.86) for the service of the period beginning on 01st January, 2017 and ending 31st December, 2017 in this statute referred to as the “Financial Year 2017” which is specified in 2nd paragraph of the Appropriation Statute No. 04 of 2016 as amended by Appropriation (Amendment) Statute No. 01 of 2017, the first schedule is hereby amended as the expenditure of the Sabaragamuwa Provincial Council which is estimated, Rupees Thirty Two Billion Four Hundred and Eighteen Million, Five Hundred and Sixty Six Thousand Three Hundred and Seventy One and Cens Ninety Nine Only (Rs. 32,418,566,371.99) for the service of the period beginning on 01st of January 2017 and ending 31st December 2017 in this statute referred to as the “Financial Year 2017” as the First Schedule hereof.
3. The limits mentioned in the Second Schedule of the Appropriation Statute No. 04 of 2016, relevant to the limits of the Advanced Accounts is hereby amended as per the second schedule hereof.
