### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Wijesundara Mudiyansele Thilakarathna Bandara Ekanayaka, Acting Minister of Lands, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the Provisions of that Act.

The allotments of land called Udabage Watta, Alupathdeniya Pahalawatta, Paluwatta Ela, depicted in the Advance Tracing No. KE/DRN/2016/299 and dated 13.10.2016, prepared by the Surveyor General, situated in the Village of Malandeniya in Atulugam Korale Minor Division in the Divisional Secretary's Division of Deraniyagala in Kegalle District in Sabaragamuwa Province and bounded as follows:

**01. Lot 'A' – Udabage Watta, Alupathdeniyapahala Watta – Extent: 0.1189 Hectare**

North: Lot No. 4 in F.V.P. 618 and Lot D (Road); East: Lot D (Road); South: Lot B (Dry Canal); West: Lot No. 4 in F.V.P. 618.

**07. Lot 'G' – Udabage Watta, Alupathdeniyapahala Watta – Extent: 1.6980 Hectare**

North: Lot F (Paluwatte Ela) and Lot No. 4 in F.V.P. 618; East: Lot No. 4 in F.V.P. 618 and Lot H (Road); South: Lot H (Road); West: Lot H (Road) and Lot F (Paluwatte Ela).



**08. Lot 'H' - Extent: 0.0702 Hectare**

North: Lot G; East: Lot No. 4 in F.V.P. 618; South: Lot No. 4 in F.V.P. 618 and Lot J; West: Lots J, F (Paluwatte Ela), Lot Nos. 4, 111 in F.V.P. 618 and Lot E.

**09. Lot 'J' - Udabage Watta, Alupathdeniyapahala Watta - Extent: 0.1562 Hectare**

North: Lot H (Road); East: Lot H (Road) and Lot No. 4 in F.V.P. 618; South: Lot No. 4 in F.V.P. 618 and Matiganna Oya; West: Matiganna Oya and Lot K (Paluwatte Ela).

**10. Lot 'K' - Udabage Watta, Alupathdeniyapahala Watta - Extent: 0.0066 Hectare**

North: Lot H; East: Lot J; South: Matiganna Oya; West: Lot No. 4 in F.V.P. 618.
