IT is hereby notified by me the governor of the North Central Province, M. P. Jayasinghe in terms of powers vested with me under the North Central Provincial Road Development Authority Statute No. 01 of 1998 according to the sub Section 10(2) in the said statute the reservation limit and the building construction limit in relation to the roadways of the Provincial Road Development Authority come within the purview of "C" and "D" categories are as follows. This notification comes in to effect from 01.01.2018.

The Reservation of the "C" and "D" category roads administered by the North Central Provincial Council is considered as 10 meters to the either side from the center line of the road and the building construction limit as 15 meters either side from the center line of the road.
