PORTS AND AIRPORTS DEVELOPMENT LEVY ACT, No. 18 OF 2011

Order under Section 3

BY virtue of powers vested in me by Sub-section 3 of Section (3) of the Ports and Airports Development Levy Act, No. 18 of 2011, I, Mangala Samaraweera, Minister of Finance and Mass Media do hereby this Order, amend the *Extraordinary Gazette Notification* No. 2049/16 of 13.12.2017 by,

1. The addition of the following Sub Paragraph immediately after Sub Paragraph (b) of Paragraph 1 :-
 - (c) “Ports and Airports Development Levy, shall be charged and levied on importation of each article specified in Column III corresponding to the H. S. Headings in Column I and H. S. Code in Column II of the Schedule III hereto, a concessionary rate of 2.5% in its corresponding entry in Column IV, on the recommendation of the Secretary, Ministry of Industry and Commerce based on a set of predetermined criteria.”
2. The addition of Schedule hereto as Schedule III, immediately after the Schedule II of the said *Extraordinary Gazette Notification* No. 2049/16.
