THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below is needed for a public purpose and will be acquired under the provisions of that Act.

Boundaries for the allotments of land containing in extent 1.0502 Hectare depicted as from Lot Letter A to E in the Advance Tracing No. MR/DVN/2016/33 and dated 19.08.2016 made by Surveyor Superintendent of Matara and situated in the Village of Talalla in Wellabada Pattu East Minior Division, Divisional Secretary's Division of Devinuwara, Matara District, Southern Province:

01. Lot 'A' – Kapuhena – Extent: 0.3279 Hectare

04. Lot 'D' – Kombugewatta – Extent: 0.0295 Hectare

North: Lot C; East: Outer Canal, Road and Lot E; South: Lot E and Pattigewatta *alias* Mahawatta claimed by Magamage Chandradasa; West: Lot C.

05. Lot 'E' – Kombugewatta – Extent: 0.0110 Hectare

North: Lot D; East: Kombugemidellamure claimed by Neel Ramasundara and others; South: Kombugemidellamure claimed by Neel Ramasundara and Pattigewatta *alias* Mahawatta claimed by Magamage Chandradasa; West: Lot D.
