#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, Gayantha Karunatilleke Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of section 5 of the land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of lands below, depicted in Advance Tracing No. KE/RWN/2017/174 and dated 12.09.2017 prepared by the Surveyor General, situated in villages of Imbulana and Anguruwella and Grama Niladhari Divisions of No. 100, Imbulana and No.105 B, Doranuwa in the Minor Division of Atulugama Korale in Divisional Secretary's Division of Ruwanwella in the Kegalle District in Sabaragamuwa Province and bounded as follows:

## 01. Lot 'A' - Gonnagahapelessa Watta *alias* Baiya Watta - Extent: 0.0036 Hectare

North: Balance portion of same land; East: Balance portion of same land and Gonnagahapelessa Watta *alias* Baiya Watta; South: Lot E and Road (R.D.A.); West: Road (R.D.A.).
