### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Four allotments of land depicted as Lots 'A' to 'D', depicted in the Advance Tracing No.: KU/BMK/2014/107 dated 19.09.2014, prepared by the Surveyor-General, situated in the Village called Hunukumbura in the Minor Division of Walgampattukorale in the Divisional Secretary's Division of Bamunakotuwa in Kurunegala District in North Western Province and bounded as follows:

01. Lot 'A' – Udupitiya Kumbura – Extent: 0.0136 Hectare  
North: Land claimed by Lionel Siriwardhane; East: Lot B; South: Balance portion of this land; West: Pradeshiya Sabha Road.

02. Lot 'B' – Udupitiya Kumbura – Extent: 0.0186 Hectare  
North: Land claimed by Lionel Siriwardhane; East: Lot C; South: Balance portion of this land; West: Lot A.
