THE LAND ACQUISITION ACT (Chapter 460)

Notice under Section 07

I, hereby given notice under Sub section (1) of Section 07 of the land of the land Acquisition Act as amended by the land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire part of the Land at left side of Madiwela East Diversion Scheme situated in the Village called Udumulla, implemented under a sub project of Metro Colombo Urban Development Project for the conservation of embankments.

Description of the land to be Acquired:

Two allotments of land in total extent of about 0.0663 Hectare, depicted as lot No. 01 and 02 in the Preliminary Plan No. Co. 9763 dated 10.05.2018 situated in the Village called Udumulla in the Grama Niladhari Division No. 502 of Udumulla - North in the Divisional Secretary's Division of Kolonnawa in Colombo District of the Western province and bounded as follows:

01. Lot No. 01
