THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act:

An allotments of land in total extent of about 0.1871 Hectare, depicted as lot A, B in the Advance Tracing No. Ya/KRV/2017/83 dated 31st July, 2017, prepared by the Surveyor General situated in the Village called Karanavai in the Grama Niladhari Division No.J/351 of Kranavai East, in the Divisional Secretary's Division of Vadamarachchi South West of Jaffna District in Northern Province and bounded as follows:
