THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Five (5) allotments of land depicted and Advanced Tracing No. GA/GFG/2017/778 dated 26.12.2017, prepared by the Surveyor - General, situated in the village called Kandewatta, Galwadugoda in the Divisional Secretary's Division of Galle Four Gravets in Galle District of Southern Province and bounded as follows:
