THE DEPARTMENT OF SPORTS DEVELOPMENT**

01	13 13.4 Under interim provisions	The qualifications set out under 7.1 of the Service Minute of the Combined Service of Officers in the field of Sports published in the <i>Gazette</i> No. 1009 dated 02 January 1998 will be made applicable in place of the education and professional qualifications referred to under 7.2.3.2.1 of the said Service Minute in the recruitment to the post of Sport Coach in the category of Supervisory Management Assistant Technical Service of the Combined Service of Officers in the field of sports up to 26.09.2021, the date on which the said officers complete five (05) years of service from the date of the said Service Minute takes effect. Note: The officers appointed to the post of Sports Coach in terms of interim provisions referred to under 13.4 without the completion of qualifications of Technical Diploma relating to the field of Sports at the level of National Vocational Qualification (NVQ 06) recognized by the Tertiary and Vocational Education Commission referred to under 7.2.3.2.1 (ii) of the said Service Minute, (a) Should complete the qualification referred to under 7.2.3.2.1(ii) of the said Service Minute before the completion of a period of five (05) years following the appointment to the post. (b) The salary increments of the officers who do not complete the qualification as per (a) above will be deferred from the date they complete a period of five (05) years up to the date they complete the qualification referred to under 7.2.3.2.1(ii).
	13.5	The officers who have earned five (05) salary increment having completed a period of five (05) years of active and satisfactory service in Grade II of the Executive Service Category of Combined Service of Officers in the field of Sports and who have demonstrated a performance at satisfactory level or above during the entire period of five (05) years preceding the date of promotion in accordance with approved procedure of performance appraisal will be promoted to Grade I of the Executive Service Category according to number of vacancies existing in the post in Grade I of Executive Service Category irrespective of the qualification referred to in 10.6.1.1.(i) and (ii).
