REVENUE PROTECTION ACT, No. 19 OF 1962

REVENUE PROTECTION ACT, No. 19 OF 1962

ORDER

By virtue of the powers vested in me by under Section 2 of the Revenue Protection Act, No. 19 of 1962, I, Mangala Samaraweera, Minister of Finance and Mass Media of the Democratic Socialist Republic of Sri Lanka, do by this Order effective from July 20, 2018, require the Director General of Customs to demand and levy on each article, specified in Column 3 of the Schedule hereto, import duty at the general rate set out in the corresponding entry in Column 5 of that Schedule or where a preferential rate is leviable and payable under the Singapore-Sri Lanka Free Trade Agreement set out in the corresponding entry in Column 4 of that Schedule under the provisions of the Schedule “A” of the Customs Ordinance (Chapter 235).



Preferential rates, which are leviable and payable on each article specified in Column 3, as set out in the corresponding entry in Column 4 of the Schedule of “A” of the Customs Ordinance, (Chapter 235), published in the *Extraordinary Gazette* No. 2049/58 of December 15, 2017 remain in force without change.
