### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, do hereby declare under Sub-Section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of lands depicted in below names and extents, depicted in the Advanced Tracing No. CO/DSO/2017/234 and dated on 05.07.2017 prepared by the Surveyor General, situated in villages called Salamulla (Ward No.7 - Salamulla within the Municipal Council limit of Kolonnawa) Megoda Kolonnawa and Gothatuwa in the Divisional Secretary's Division of Kolonnawa in Colombo District of the Western Province and bounded as follows.

##### 1. Lot No. 01 – Hawed Dam – Extent: 0.0004 Hectare
