Amendment rules formulated under the Cooperative Employees' Pensions Statute No. 06 of 2010 of Western Provincial Council

AS per powers entrusted to me under Section 23 of the Cooperative Employees' Pensions Statute No. 06 of 2010 of Western Province, I, Kejitan Lalith Wanigarathne, the Minister of Roads, Transport, Cooperative Development and Trade, Housing and Construction, Estate Infrastructure Facilities, Industries and Rural Development do hereby amend the rules formulated under the said Section of Cooperative Employees' Pensions Statute No.06 of 2010 and published in the Extraordinary Gazette paper No. 1698/22 dated 24th March 2011 as follows. These amendment rules shall be enforced from the date of their publication in the Gazette paper.

(1) By substituting the following rule instead of rule 3(2), the said rule is amended as follows:

According to the matters contained in this rule, an employees recruited to the permanent service subsequent to the date of enforcement of these rules, within 90 days from the date of confirmation of his service by the Wstern Provincial Cooperative Employees' Commission shall present to the Director an application prepared as prescribed by these rules.

(2) Inclusion of a new rule as 3(3) immediately after rule 3(2) as follows.

In case any problematic situation occurs regarding contribution to the Western Provincial Cooperative Employee's Pension Scheme, the Director shall reach into a decision on the agreement of the Control Board.
