#### MUTUAL ASSISTANCE IN CRIMINAL MATTERS ACT, No. 25 of 2002

#### **Order under Section 2**

BY virtue of the powers vested in me by Sub-section (1) of Section 2 of the Mutual Assistance in Criminal Matters Act, No. 25 of 2002, I, Thalatha Atukorale, Minister of Justice and Prison Reforms, do by this Order declare that the provisions of the aforesaid Act, shall apply in respect of any country that is -

- (a) a party to -
  - (i) the United Nations Convention against corruption specified in the Schedule I hereto; and
  - (ii) the Council of Europe Convention on Cybercrime specified in the Schedule II hereto;
- (b) a member of the Commonwealth specified in the Schedule III hereto.

The Order published in *Gazette Extraordinary* No. 1297/1 of July 14, 2003, is hereby rescinded without prejudice to anything previously lawfully done thereunder.
