Revocation Order under Section 39 (1)

By the Order No. 309 of 2017 dated 22.11.2017 made under the Proviso (a) to Section 38 of the Land Acquisition Act (Chapter 460) and published in the *Gazette Extra Ordinary* No. 2047/13 dated 28.11.2017 the land Specified more fully in the Schedule below was vested in the Democratic Socialist Republic of Sri Lanka.

But the possession of the said land has not yet been taken for and on behalf of the Democratic Socialist Republic of Sri Lanka.
