The Board of Investment of Sri Lanka (Fees and Charges) Rules published in *Gazette Extraordinary* No. 1595/15 dated 31st March 2009 ; No. 1634/13 dated 28th December, 2009 ; No. 1737/13 dated 22nd December, 2011 and No. 1789/21 dated 19th December 2012 ; No. 1947/27 dated 30th December 2015 and No. 2025/43 dated 30th June 2017 the matters and the amounts specified in the respective Columns I and II are hereby amended as follows:-

1.
