I hereby give notice, under Sub section (1) of Section 7 of the land Acquisition Act, (Chapter 460) as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the following Land for a public purpose.

Description of the land or servitude to be acquired:
