#### THE JUDICATURE ACT, No. 2 OF 1978

##### Order under Section 3

BY virtue of the powers vested in me by Section 3 of the Judicature Act, No. 2 of 1978, I, Thalatha Atukorale, Minister of Justice and Prison Reform in consultation with the Chief Justice and the President of the Court of Appeal, do by this Order amend the Schedule of the Order published in the *Gazette Extraordinary* No. 1679/40 of November 10, 2010 as last amended by *Gazette Extraordinary* No. 2066/18 of April 10, 2018 as follows :-
