ORDER UNDER PROVISIO (a) TO SECTION 38

01. **Acquiring Officer.**– Divisional Secretary, Dompe.

02. **Description of the land.**– Two allotments of land depicted in the Preliminary Plan No. GAM 4063 dated 20.12.2017 prepared by the Surveyor General, situated in the Village called Weralugampola in No. 392 A, Werelugampala Grama Niladhari Division in the Gangabadapattuwa Minor Division, in the Divisional Secretary’s Division of Dompe of Gampaha District in Western Province and bounded as follows.

01. **Lot No. 1 – Punchi Nedungolla – Extent: About 2.4458 Hectare**
