**MINUTE OF THE CENTRAL PROVINCIAL PUBLIC MANAGEMENT ASSISTANT'S SERVICE
AMENDMENT No. 02**

THE Hon. Governor of Central Province has approved to amend the Minute of the Central Provincial Public Management Assistant's Service revised by the *Gazette Extraordinary* of the Democratic Socialist Republic of Sri Lanka No. 2047/43 dated 30.11.2017 and published in the *Gazette Extraordinary* of the Democratic Socialist Republic of Sri Lanka No. 1869/4 dated 30.06.2014, as follows:

1. The Section 7.3.2.1 of Para. 07 is revised as follows :

7.3.2.1 Educational Qualifications

Shall have passed the G. C. E. (O/L) Examination in six (06) subjects including Sinhala/Tamil/English and Mathematics/ Arithmetic/ Pure Mathematics/ Elementary Mathematics/ Commercial Arithmetic with at least two credit passes at not more than two sittings.

The Section 7.3.3.1 of Para. 07 is revised as follows :

7.3.3.1 Written Examination

<i>Subjects</i>	<i>Maximum Marks</i>	<i>Pass Marks</i>
Language ability and Eligibility Test of Management Assistants' Service	100	40
Aptitude	100	40



Candidates who have scored minimum of 40% marks for each subject and obtained an aggregate of at least 50% of the total marks of the examination that's mean total marks of 100 or more and have fulfilled the basic educational qualifications required for recruitment shall be appointed in the order of the merit and the number of vacancies. (Annex 03)

2. The term “Efficiency Bar Examination” shall be included in substitution for the term “Examination” in sections 02, 04 and 05 under Annex 06.
3. Following shall be included as No. 06 at the end of Annex 06.

06. Officers shall be exempted from the requirement of passing the Efficiency Bar Examination prescribed for the officers in Grade I of Central Provincial Public management Assistant Service on successful completion of the 10 day course including the basic principles of which a Senior Officer in public service should be aware, within 05 years from the date of promotion to Grade I.

- i. Conducting authority of the course : Central Provincial Chief Secretary and Director General of Combined Services
- ii. Duration of the course : The notification for calling applications relevant to the training course prescribed for Grade I shall be published in the first quarter of every year and the number of training course conducted shall be determined in considering the number of applications received.
- iii. Syllabus of the course

<i>Module</i>	<i>Duration</i>
Disciplinary Procedure of the Public Service	02 days
Public Finance and Assets Management	03 days
Organizational Productivity	02 days
Procurement Procedure	02 days
Right to Information Act and Customer Care	01 day

Note :

01. Officers shall be exempted from the Efficiency Bar examination prescribed for Grade I of Central Provincial Public Management Assistants' Service strictly on successful completion of the relevant five modules Course, which shall be conducted by Public Service Training Institute on the approval of the Central Provincial Chief Secretary or the Director General of Combined Services as determined by the Central Provincial Public Service Commission.

02. Further, it is required to either to pass the efficiency bar examination prescribed for Grade I of Central Provincial Public Management Assistants' Service or successfully complete the five modules prescribed under the syllabus of the course mentioned in Part 6. No exemption shall be made from the Efficiency Bar examination on the basis of passing subjects as a combination of the subjects of the examination and the subjects of the course.
