THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The Allotments of below mentioned lands depicted as Lots 'A' to 'M' (Lots 11) in extent of about 2.1920 Hectares, in the Advance Tracing No. H/BLA/RDA/2018/258 prepared by the Senior Superintendent of Surveys, Hambanthota District on behalf of the Surveyor-General, situated in the Villages of Nayakawatta, Gatamanna South in the Minor Division of Giruwa Pattuwa South in the Divisional Secretary's Division of Beliatta in Hambantota District in Southern Province and bounded as follows:
