THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The Allotments of below mentioned lands depicted in the Advance Tracing No. KE/GLG/2017/364 of 04.05.2018, prepared by the Surveyor-General, situated in the Village of Arandara in the Grama Niladhari Division of No. 64A, Arandara in the Minor Division of Kandupita Pattuwa in the Divisional Secretary's Division of Galigamuwa in Kegalle District in Sabaragamuwa Province and bounded as follows:

01. **Lot 'A' – Mailands Watta – Extent: 3.3025 Hectares**
North: Lots C and B; East: Lots C, D and E; South: Lot H; West: Koswatta Kumbura.
02. **Lot 'B' – Extent: 0.0133 Hectare**

08. **Lot 'H' – Extent: 0.1721 Hectare**
North: Koswatta Kumbura, Lots A, C and G and Milands Watta; East: Lot J; South: Lots J, K and Atala Watta Batupitiya Division; West: Atala Watta Batupitiya Division, Road and Koswatta Kumbura.
