#### **Notice under Section 7**

#### My Reference No.: DIVBA/LND/ACQSTN/01/01/02.

I, hereby give notice under Sub-section (1) of Section 7, of Land Acquisition Act No.28 of 1964 (Amended) that the Government intends to acquire the following lands which are required for a public purpose.

#### Description of the Land to be Acquired:

Four allotment of land depicted in the Preliminary Plan No. KU.2419 situated in the village called Hunukumbura in Dewamadi Hathpaththuwe Walgampaththu Korale in the Grama Niladhari Division No. 1211 of Mirihampitiya in the Divisional Secretary's Division of Bamunakotuwa in Kurunegala District of the North Western Province and more fully described as follows.
