- 2. The expenditure of the Sabaragamuwa Provincial Council which is estimated Rupees Thirty Two Billion Eight Hundred and Thirty Four Million, Four Hundred and Eight Thousand One Hundred and Twelve and Cents Thirty Five only (Rs. 32,834,408,112.35) for the service of the period beginning on 01st of January, 2018 and ending 31st December, 2018, which is specified in 2nd paragraph of *Gazette Notification* No. 2052/15 dated 03.01.2018, which is amended by fourth supplementary financial statement for the year 2018 and assented on 13.11.2018, is hereby amended as, Rupees Thirty Two Billion Nine Hundred and Thirty Four Million, Four Hundred and Eight Thousand One Hundred and Twelve and Cents Thirty Five Only, (Rs. 32,934,408,112.35) and grant permission to Chief Secretary of this Province and other Accounting Officers to disburse the same from the Sabaragamuwa Provincial Council Fund.
