I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No.28 of 1964, that the Government intends to acquire the following Land/Servitude which is required for a public purpose mentioned below.

#### Notice under Section 7

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act, No.28 of 1964, that the Government intends to acquire land/servitude right of the following Land which is required for a public purpose.

Description of the Land/servitude to be Acquired:

To obtain the servitude rights of an allotment of land for laying pipe lines from Nawayalavila Reservoir to Nalagama Water Treatment Plant under Tangalle Water Supply Project.

Seven allotments of lands called as Suriyagahawaththa, Galekella, Galwaththa, Nugekumbura Karamane Kumbura, Berawathu Kumbura depicted as lot No. 857, 858, 859, 860, 861, 862, 863 with total extent about 0.8441 Ha. in the preliminary plan dated 21.10.2015 and F.
