(a) the Trustees of the said Trust named above and their successors for the time being duly appointed under the Deed of Trust bearing No. 486 of June 25, 2019, attested by Tharini Prakarshi Dias Senerath Gunasekera, Notary Public of Colombo, shall be a body corporate with perpetual succession and a common seal under the name and style of "the Trustees of the Society of Jesus in Sri Lanka";

- the said Trustees shall, by the said name and style, be able and competent in law to sue and be sued, to answer and to be answered, to defend and be defended, in any court in Sri Lanka or elsewhere in all cases and actions arising in relation to the said Trust.
