#### CONFERMENT OF POWERS

BY VIRTUE of the powers vested in me by section 2(2) of the Co-operative societies Law No.5 of 1972 as amended by Co-operative societies (Amendment) Act, No. 32 of 1983 and the Co-operative societies (Amendment) Act, No. 11 of 1992 read in conjunction with provincial council (Consequential Provisions) Act No. 12 of 1989, I, Shan Wijayalal De Silva Governor of Eastern Province do hereby confer on each of the persons named in column I in the schedule hereto, who have been appointed to assist the Commissioner of Co-operative Development and Registrar of Co-operative societies of the Eastern province, such powers of the Registrar under the Co-operative societies Law, No. 5 of 1972 as amended by Co-operative societies (Amendment) Act, No. 32 of 1983 and the Co-operative societies (Amendment) Act, No. 11 of 1992 and the rules there under and which are more fully described in Column III of the said schedule in respect of their area with effect from the dates shown in Column II of the said schedule, to be exercised by the aforesaid during their tenure of office.
