AMENDMENT

KARIYAKSHAMA SEVA VIBHUSHANAYA

Orders

REGULATIONS mentioned in the following paragraphs, numbered as Fourthly, Seventhly, Eighthly, Ninthly, Eleventhly, Twelfthly, Thirteenthly, Fourteenthly and Fifteenthly: published in the Government *Gazette Extraordinary* Number 412/20 dated 01.08.1986, of the Democratic Socialist Republic of Sri Lanka are hereby amended by His Excellency the President:

Fourth Paragraph

Seal

: It is ordained that the period of service requisite to qualify for the Decoration shall be an aggregate of twenty five years Efficient Commissioned Service on the Active Strength of the Sri Lanka Army Volunteer Force, and the ranks shall be Brigadier and above, subject to such conditions as may be laid down in the regulations hereinafter mentioned, provided that the period of service so tendered previously to reward any other medal for Efficient Service in the Sri Lanka Army Volunteer Force, may be reckoned to reward the Kariyakshama Seva Vibhushanaya.



Seventh Paragraph

: It is ordained that service shall be reckoned as qualifying service for the Decoration if such service has already been reckoned for the Efficiency Medal, or, the Kariyakshama Seva Padakkama.

Eigth Paragraph

: It is ordained that Officers who have the necessary qualifying service shall not be awarded the Decoration unless they are recommended by the Commandant of the Sri Lanka Army Volunteer Force in which the period of service requisite to qualify for the Decoration is completed; and, finally approved by the Commander of the Sri Lanka Army, as efficient and thoroughly capable Officers deserving in every way for the Decoration.

Ninth Paragraph

: It is ordained that a recipient of this medal shall not be eligible for a second conferment or conferment of clasp during his lifetime.

Eleventh Paragraph

: It is ordained that the reproductions of the Decoration in miniature, which may be worn on certain occasions by those upon whom the Decoration is conferred, shall be half the size of the Kariyakshama Seva Vibhushanaya.

Twelfth Paragraph

: It is ordained that sealed patterns of the Kariyakshama Seva Vibhushana, and its miniatures, are held by the appropriate authority at the Sri Lanka Army Headquarters.

Thirteenth Paragraph : It is ordained that it shall be competent for me, my elected successors, or by and order under my Seal and Signature, or on a recommendation to that effect by, or, through the Secretary Defence to cancel, and annul the award of the Decoration in respect of any person; and that thereupon his name is struck off the register where such awards are recorded; but it shall be competent for me or one of my elected successors to restore the Decoration when such recommendation has been withdrawn.

Fourteenth Paragraph: It is ordained that the Decoration shall be conferred under such regulation as to grant forfeiture, restoration, and other matters in amplification of this my Proclamation as may with my approval signified through the Secretary Defence be issued from time to time by the Commander of the Sri Lanka Army.

Fifteenth Paragraph

: I reserve to myself and my elected Successors the full power of annulling, abrogating, augmenting, interpreting or dispensing with these rules and regulations, or any part thereof by a Notification under my Seal and Signature, or under my Command.

AMENDMENT

KARIYAKSHAMA SEVA PADAKKAMA

Orders

REGULATIONS mentioned in the following paragraphs, numbered as Fourthly, Fifthly, Sixthly, Seventhly, Eighthly, Ninthly, Tenthly, Eleventhly, Twelfthly and Thirteenthly published in the Government *Gazette Extraordinary* Number 412/20 dated 01.08.1986, of the Democratic Socialist Republic of Sri Lanka pertaining to Kariyakshama Seva Padakkama are hereby amended.

Whereas I am desirous of rewarding long, efficient loyal service, and exemplary conduct of proven capacity by Commissioned Officers, Warrant Officers, Non-Commissioned Officers and Men of the Sri Lanka Army Volunteer Force.

Fourth Paragraph

It is ordained that the Medal shall be awarded to Commissioned Officers, Warrant Officers, Non-Commissioned Officers and Men of the Sri Lanka Army Volunteer Force who have completed an aggregate of eighteen years of Efficient Service on the Active list of the Sri Lanka Army Volunteer Force subject to such conditions as may be laid down in the regulations hereinafter mentioned and the medal shall be awarded to those who do not receive any other medal for the efficient service on active list of the Sri Lanka Army Volunteer Force for the period of service concerned and such service is not counted to award any other medal.

Fifth Paragraph

It is ordained that the award of the Medal to such Commissioned Officer, Warrant Officers, Non-Commissioned Officers and Men of the Sri Lanka Army Volunteer Force should be recommended by the Commanding Officer of the Unit in which the period of service requisite to qualify for the Medal is completed; and such recommendation is certified by the Colonel of the Regiment and the Commandant of the Sri Lanka Army Volunteer Force and finally approved by Commander of Sri Lanka Army as efficient and thoroughly capable Commissioned Officers, Warrant Officers, Non-Commissioned Officers or Men deserving in every way to award the Medal.

Sixth Paragraph

: It is ordained that Commissioned Officers, Warrant Officers, Non-Commissioned Officers and Men on the Reserve of the Sri Lanka Army Volunteer Force are entitled to claim for this Medal, if at, the time they were placed on the Reserve, they had such qualifying service requisite for the Medal.

Seventh Paragraph

: It is ordained that a recipient of this medal shall not be eligible for a second conferment or conferment of clasp during his lifetime.

Eighth Paragraph

: It is ordained that the Eighth regulation ordained previously to be null.

Ninthly Paragraph

: It is ordained that sealed patterns of the Kariyakshama Seva Padakkama in miniature, which may be worn on certain occasions by Commissioned Officers and Warrant Officers on whom the Medal is conferred, shall be half the size of the Kariyakshama Seva Padakkama.

Tenthly Paragraph

: It is ordained that sealed patterns of the Kariyakshama Seva Padakkama and its miniatures are held by the appropriate authority at the Sri Lanka Army Headquaters.

Eleventh Paragraph

: It is ordained that it shall be competent for me or my elected successors, or, on a recommendation to that effect by, or, through, the Secretary Defence by an order under my seal and signature to cancel, and annul the award of the Medal, in respect of any person; and that thereupon his name is struck off the Register where such awards are recorded. But it shall be competent for me, or one for my elected successors to restore the Medal, when such recommendation has been withdrawn.

Twelfth Paragraph

: It is ordained that Medal shall be conferred under such regulations as to grant, forfeiture, restoration and other matters in amplification of this, my Proclamation as may with my approval signified through the Secretary Defence be issued from time to time by the Commander of the Sri Lanka Army.

Thirteenth Paragraph : I reserve to myself and my elected Successors the full power of annulling, abrogating, augmenting, interpreting or dispensing with these rules and regulations, or any part thereof by a Notification under my Seal and Signature, or under my Command.
