THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land described below are needed for a public purpose and will be acquired under the provisions of that Act.

The Allotments of land depicted in the Advance Tracing No. GA/ GFG/2019/391 of 08.07.2019 prepared by the Surveyor-General, situated in the Villages of Deddugoda South and Dangedara in the Grama Niladhari Divisions of Dangedara East, 97D and Deddugoda South, 101A in the Divisional Secretary's Division of Galle - Four Gravets in the District of Galle in Southern Province and bounded as follows:

01. Lot 'A' – Mahamoragodawatta – Extent: About 0.0015 Hectare

North: Mahamoragodawatta claimed by D. P. Y. Gamage; East and South: Road; West: Mahamoragodawatta claimed by D. P. Y. Gamage.

02. Lot 'B' – Mahamoragodawatta – Extent: About 0.0014 Hectare

North: Road; East: Mahamoragodawatta claimed by B. P. Udaya Kasun; South and West: Road.

03. Lot 'C' – Mahamoragodawatta – Extent: About 0.0013 Hectare

North: Road and the land acquired for Moragoda canal; East: Wellabagala Eladdara Ovita claimed by H. M. Dharmasena; South: Road and Lot D; West: Road.

04. Lot 'D' - Extent: About 0.0010 Hectare

North: Road and Lot C; East: Lot C, Wellabagala Eladdara Ovita claimed by H. M. Dharmasena and Road; South: Wellabagala Eladdara Ovita claimed by unknown owner and Lot E; West: Road.

05. Lot 'E' – Kurunduwatta, Pashaul Ovita – Extent: About 0.0021 Hectare

North: Road and Lot D; East: Road and Wellabagala Ela Addara Ovita claimed by unknown owner; South: Wellabagala Ela Addara Ovita claimed by unknown owner; West: Road.

06. Lot 'F' – Kurunduwatta, Pashaul Ovita – Extent: About 0.0040 Hectare

North: Kurunduwatta, Pashaul Ovita claimed by Sajith Dayarathna and land acquired for Moragoda canal; East: Road; South: Road and Kurunduwatta, Pashaul Ovita claimed by unknown owner; West: Kurunduwatta, Pashaul Ovita claimed by Sajith Dayarathna.
