Remark 01included under 7.3.2.1	Salary increments of officers recruited under these minimum qualifications stated in Schedule VII of the Service Minute and failing to fulfill the basic educational qualifications prescribed in the Service Minute in relation to the subject they were recruited for within 05 years from the date of their recruitment should be stopped until they complete the relevant qualifications. The relevant promotion of such officers to Grade II will be delayed by a period equal to the additional period they spent to complete the relevant qualifications.

(a) Remark 02 of Section 8 is applicable (b) Selections (II) and (III) of 10.1.1 are amended as follows for the officers who have completed the qualifications in Section 14(a) of the Service Minute No.1070/13 of 11.03.1990 and they will be promoted as from the date they complete other qualifications excluding the one referred to in 10.1.1 (VIII). * Should have completed at least seven (07) years of active and satisfactory period of service in Grade III of the category of service and earned seven (07) salary increments as at the date of qualifying for promotion. * Should have demonstrated a performance at satisfactory level or above during seven (07) years immediately preceding the date of promotion in accordance with the approved procedure of performance appraisal. (c) In terms of Section 17 of the Service Minute No. 1070/13 of 11.03.1990, the officers who have not fulfilled the requirement of passing the English Language and have been recruited to the Sri Lanka Teacher Educators Service before 01.01.2002 should complete a Course in English Language of a duration not less than two weeks from an institution decided by the Secretary of the Ministry of Education. Officers who have passed the subject of English in the General Certificate of Education (Ordinary Level) will be reckoned as officers having fulfilled this qualification.
