FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE KARACHCHI PRADESHIYA SABHA UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of member of Karachchi Pradeshiya Sabha has fallen vacant by reason of Resignation;
