#### FILLING OF A VACANCY IN THE OFFICE OF MEMBER OF THE KARACHCHI PRADESHIYA SABHA UNDER SECTION 66A(1)(a) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)

WHEREAS the office of member of Karachchi Pradeshiya Sabha has fallen vacant by reason of Resignation ;

AND WHEREAS the Secretary of the Ilankai Tamil Arasu Kadchi, the recognized political party to which Sathasivam Ponnuththurai the member belonged, was required by me under Section 66 A (1)(a) of the aforesaid ordinance, to decide upon the member of that No. 8 Wattakkachchi of Karachchi Pradeshiya Sabha who belongs to such party and is not disqualified under Section 9 of the Local Authorities Elections Ordinance and who shall be declared elected as a member within a period of thirty (30) days ;
