THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Gayantha Karunatilleke, Minister of Lands and Parliamentary Reforms, do hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Allotments of lands deccribed below, depicted in the Surveyor General's Advance Tracing No. Ma/LGG/2014/398 of 02.04.2016, situated at Maoya Village (within Topo.P.P.20) in Gangala Udasiya pattuwa Minor Division of Laggala Pallegama Divisional Secretary's Division, Matale District, Central Province and bounded as follows.

01. Lot 'A' - Maoya - Extent: 0.0703 Hectare

North: Maoya land claimed by Mahaweli Authority and Road; East: Lot B; South: Road claimed by Mahaweli Authority and Maoya land; West: Maoya land claimed by Mahaweli Authority.

02. Lot 'B' - Maoya - Extent: 0.0456 Hectare

04. Lot 'D' - Maoya - Extent: 0.4852 Hectare

North, East, South and West: Maoya land claimed by Mahaweli Authority.
