John Senevirathna and powers and functions specified in the following Schedule II are delegated to the State Minister of Development Banks and Loans, Hon. Shehan Semasinghe in terms of the provisions of the Article 44(5) of the constitution and the both State Ministers have the opportunity of inquiring, mediating and coordinating all functions coming within the scope of work of the Ministry.
