#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Gayantha Karunatileke, Minister of Lands and Parliamentary Reforms, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The Allotments of land described as following names and extents in the Advance Tracing No. KU/PLG/2018/01 dated on 29.01.2018, prepared by the Surveyor-General, situated in the Village of Serapiswatta in the Grama Niladhari Division of No. 993, Serapiswatta in the Minor Division of Dambadenihatpattuwa in the Divisional Secretary's Division of Polgahawela in Kurunegala District in North Western Province and bounded as follows:

**01. Lot 'A' – Serapiswatta – Extent: About 2.5721 Hectares**
